NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Extend at ground floor level, raise and alter roof height to create 1st floor accommodation with balcony and alter raised terrace area to north (rear) elevation and install external insulating render system.

LOCATION: Shinglewood, Rue De La Ronde Cheminee, Castel.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1. All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 13/10/2024 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

OFFICER'S REPORT

Brief Description of the site:

Shinglewood is a detached dwelling situated to the north of Rue de la Ronde Cheminee. Vehicular access is to the east of the dwelling and leads to a garage to the northwest of the dwelling and a parking area to the south east of the existing stable block. The stable block is a detached building with painted exterior and PVCu doors and windows. To its north is a timber building raised on a concrete base and used as a tack store. A wall exists to the northwest site boundary and hedges mark the southeast and north east boundaries. The land to the northeast of the stables, garage and parking area has been divided into paddocks for the grazing of horses.

The application relates to the erection of a first floor extension to Shinglewood to provide a pitched roof dwelling with the first floor accommodation served by rooflights and pitched roof dormers. A one and a half storey extension is proposed to the rear of the dwelling incorporating an inverted balcony with associated extension to ground floor raised terrace. Insulating render is proposed to the exterior of the dwelling.

The site is located Outside of the Centres as designated in the Island Development Plan.

FULL/2021/1813 – partially demolish outbuilding, extend at ground floor level and raise roof height to create first floor accommodation with external staircase to outbuilding/garage – granted

FULL/2021/1774 - Erect stables to north of existing stables, install solar panels and alterations to existing stables. Install sand school, remove hedge and erect fencing – under consideration

FULL/2021/1813 – partially demolish, extend at ground floor level and raise roof height to create first floor accommodation with external staircase to outbuilding/garage – under consideration

Conclusion/Brief comment:

Shinglewood is situated between two, two-storey dwellings and the proposed increase in height will not appear out of keeping in the street scene. The design and appearance of the proposed extensions represents a good standard of design that respects the local built environment. The scheme has considered the health and well-being of occupiers of the development in its design and offers flexible accommodation that can adapt to the needs of occupiers over time. The scheme therefore accords with the aims of Policies GP8, GP9 and GP13 of the Island Development Plan in this respect.

The development is to be set off the site boundaries and will not result in unacceptable overshadowing or loss of light to the occupiers of the adjoining dwelling to the west. Window openings in the west elevation of the development are limited and will not result in overlooking and loss of privacy to the occupiers of this adjoining property. The siting of Shinglewood in its plot ensures that the proposed balcony will not result in unacceptable overlooking to the occupiers of the adjoining dwelling. Windows and doors in the proposed east elevation will face the driveway and hedge boundary of the site and will not result in a loss of privacy to the east. In this respect the scheme accords with the aims of Policies GP8, GP9 and GP13 of the Island Development Plan.

With regard to Policy GP9: Sustainable Development, it has been demonstrated that the proposed development will comply with Building (Guernsey) Regulations 2012 and therefore has taken into account the use of energy, resources and any adverse impact on the environment.

In view of the above it is recommended planning permission is granted for the proposed development.
