NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect garden room with veranda and shepherds hut to south boundary (Retrospective)

LOCATION: Les Morigneaux, Les Ozouets Road, St. Peter Port.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

This notification of grant of permission refers solely to the proposals referred to above as described in your application received as valid on 22/10/2021 and the drawings referred to below. This grant of permission is subject to the following conditions:-

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 17/11/2024 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

For the avoidance of doubt, this decision permits the proposed garden room and shepherds hut to be used only for purposes incidental to the enjoyment of the dwelling house. Any use in connection with a trade or business would require a separate grant of planning permission.

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

In reaching this decision the Authority took into account any written consultations made under Section 11(1) of the Land Planning and Development (General Provisions) Ordinance, 2007 ('the Ordinance'). A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

Les Morigneaux is a detached dwelling situated to the west of Les Ozouets Road. The dwelling is set back from the road and to the rear of adjoining residential development to the south of the site.

The application relates to the erection of a mono-pitched roof garden room with verandah to the front/east of the dwelling and a shepherds hut to the south of the property. The application is retrospective as the work has been carried out.

The application sets out that the garden room has been erected utilising the concrete base of a former garage. The shepherds hut is proposed to serve as a home office space for the property.

The site is located Outside of the Centres as designated in the Island Development Plan.

Conclusion/Brief comment:

The timber clad outbuilding represents a good standard of design as a detached structure within the frontage area of Les Morigneaux. The height of the building and break in boundary landscaping etc. does mean however, that the building is visible from the road and adjoining dwellings. Although not strictly in keeping with the character of the local built environment (where outbuildings tend to be located to the side or rear of dwellings), the garden room and store would not have an unduly harmful effect on the area. Furthermore, established roadside boundary landscaping on the site also reduces the impact of the building on the character of the locality.

The proposed building is set adjacent to the side site boundary and has a pitched roof sloping away from the adjoining dwelling. The proposed building will not result in unacceptable overshadowing or loss of light to the occupiers of the adjoining property given that the building is situated to the north of this adjoining dwelling and that the garage of the neighbour is situated adjacent to the common boundary. Fenestration in the building is limited to the north and east elevations and will not result in unacceptable overlooking or loss of privacy to surrounding occupiers.

The shepherds hut is situated to the south of the dwelling, adjacent to the south site boundary. The size, siting and appearance of this structure is such that it will not result harm to the character and appearance of the locality or the amenities of surrounding occupiers with regard to overlooking or overshadowing.

With regard to Policy GP9: Sustainable Development, it has been demonstrated that the proposed development will comply with Building (Guernsey) Regulations 2012 and therefore has taken into account the use of energy, resources and any adverse impact on the environment.

Overall, the scheme meets the aims of Policies GP8, GP9 and GP13 of the Island Development Plan.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.

In view of the above it is recommended that planning permission is granted for the proposed development. An informative note should be placed on the permission

regarding the use of the buildings as ancillary accommodation associated with Les Morigneaux.
