NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Raise roof ridge height to north (rear) elevation to create first floor and alterations to fenestration.

LOCATION: Rosedale, La Moye Road, Vale.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 14/11/2024 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

For the avoidance of doubt, this decision permits the conversion of the outbuilding to be used as an integral part of and incidental to the principal dwelling presently known as Rosedale. It does not permit the creation of a separately occupied annex or an independent dwelling. This would require a separate grant of planning permission and involve different planning policy considerations.

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Rosedale' is a one and a half storey dwelling with a single storey wing to the west elevation and a garage and outbuilding to the rear (north). The dwelling is set back from and faces south onto Le Rochelle Road and a protected monument 'Rocque se Cas', which is a cobbled road.

The property is located Outside of the Centres and is within the Les Mielles Conservation Area as defined in the Island Development Plan.

There is no relevant history pertaining to this application.

Conclusion/Brief comment:

This application is to raise the roof ridge height of the rear outbuilding to create first floor level to north (rear) elevation, alterations to fenestration and create a link at the back of the garage between the main dwelling and proposed additional accommodation.

The design of the proposed scheme has taken into consideration the conservation area and adjacent protected monument. Views up and down the protected road would not significantly change, apart from a new dormer on the east facing roof slope of the outbuilding whose external wall is part of the roadside boundary. The design and external appearance of the scheme is not considered to impact upon the special quality of the surrounding conservation area, nor on the setting of the protected monument.

The additional first floor dormer was initially cause for some overlooking concerns, but having been to site, it has been assessed that the primary overlooking would be across the road into the neighbours parking area and not their private amenity space. There would be some oblique views to the southeast towards the private amenity space, but the distance is sufficient enough not to warrant a refusal. Therefore, the design, scale and massing of the new extension is not considered to have a detrimental effect on any of the immediate neighbours.

The proposals achieve a good standard of design, are well related to the main dwelling and will use materials which complement the existing materials. The extension will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

Policy GP9, Sustainable Development, seeks to ensure all new development takes into account the use of energy and resources and any adverse impacts on the environment. There has been sufficient information provided with the application to comply with the requirements of this policy.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
