NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect single storey extension with 1st floor terrace and flat roof extension to east (side) elevation, extend at 1st floor level and erect porch to north (front) elevation. Infill one existing vehicle access and widen/alter remaining vehicle access.

LOCATION: La Cotte, Rue Des Hougues De Noirmont, Vale.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 03/03/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Le Cotte' is a large detached 1970's two storey dwelling which is set back from and faces north onto Rue des Hougues se Noirmont. There are neighbouring properties to the east and west and a long garden to the south which is bound by Les Croutes road. There is a garage and vehicular entrance from the south boundary as well as a vehicular entrance from Rue des Hougues de Noirmont in the north. The property is located Outside of the Centres as defined in the Island Development Plan.

Relevant History:

FULL/2022/0006 – Alter vehicular access and install gates to south boundary (Retrospective) – Approved February 2022.

Conclusion/Brief comment:

This application is to erect a single storey garage, side extension with first floor terrace above, to the east elevation. Extend at first floor level and erect porch to the north front elevation and infill one of the existing north boundary vehicle accesses and widen/alter the remaining vehicle access.

Removing one of the vehicle access on the northern boundary is considered a good idea reducing the amount of access points onto the highway, enlarging the other access improves sight lines and along with the ability to turn around on site means

that highway safety has been improved and therefore the proposals for the northern boundary comply with the relevant policies.

Overall the proposals are considered to achieve a good standard of design, using materials which complement the existing materials. The extensions will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

The scale and massing of the new extensions are not considered to have a detrimental effect on the character and amenity of the surrounding area, but initially there were some concerns about the size of the roof terrace above the proposed garage and the possible overlooking into the neighbours garden to the southeast. Following a deferral amended plans were submitted which reduce the size of the terrace, retracting the south balustrade by approximately 2m. The privacy wall along the east boundary remain the full length, which minimises the opportunity for overlooking. The proposals are now considered not to have any impacts on either of the immediate neighbours.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
