NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Demolish chimney and extension, erect single storey extension with raised terrace and terrace at 1st floor level, install rooflight to west (front) elevation, erect single storey flat roof extension to south (side), install external insulating render and alterations to fenestration.

Conditions and reasons:-

1. All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 17/03/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Ecllaer Vaert' is a detached mid-20th century bungalow, which sits at a much higher ground level than, and faces west, onto Houmet Lane which runs along the western boundary. To the north, at the same ground level and to the south at road level, are neighbouring properties. There is a neighbouring property to the east and across the road to the west is an open field.

The property is located Outside of the Centres as defined in the Island Development Plan.

Conclusion/Brief comment:

This application is to demolish the chimney and rear extension and erect single-storey flat roof extension incorporating a roof terrace, chimney and a raised terrace. The scheme also proposes to install a rooflight to the front roofslope and to erect a single-storey extension to the rear/east elevation. Insulating render is also proposed along with alterations to fenestration.

The proposed single-storey extensions are low profile and achieve a good standard of design, using materials which complement the existing materials. The extensions

will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

The scale and massing of the new extensions are not considered to have a detrimental effect on the character and amenity of the surrounding area, nor will they have any impact on either of the immediate neighbours with regard to overshadowing or loss of light.

The front terrace is part of the application because the land falls away fairly steeply, giving the appearance of a raised terrace. The dwelling is not easily seen from the road and the terrace is not considered to affect the character of the area.

The first floor terrace above the front extension will be reached by an external staircase on the south elevation. From the stairs and first floor terrace the views are predominantly to the west, but there will be opportunity to look southward towards the neighbouring property. The views will only be into the front parking area and not to any of the neighbours private amenity spaces and the distance to the boundary is approximately 10m. Therefore, the proposed first floor terrace is considered to be acceptable and will not result in unacceptable overlooking and loss of privacy.

The rooflight/lantern, alterations to fenestration proposed and application of an external insulating render system accord with all relevant policies in the IDP.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
