NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Demolish wall and widen access to create vehicle access and parking area and erect fence to east boundary of parking area.

LOCATION: La Rochelle, Rouge Huis Avenue, St. Peter Port.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development

(Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 18/08/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any

other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Brief Description of the site:

The property known as 'La Rochelle' is a Victorian two storey mid-terraced dwelling, which is slightly set back from and facing east onto Rouge Huis Avenue. The attached dwellings are to the north and south, neighbouring properties to the east across the road and a rear access road to the west with garages beyond. The property is located within the St Peter Port Main Centre Outer Area and Conservation Area as defined in the Island Development Plan.

There is no relevant history pertaining to this application.

Conclusion/Brief comment:

This application is to demolish the existing west boundary wall and erect a fence and gate 5m to the east to allow vehicular parking at the rear of the property.

Although walls are features of the Island the application relates to the removal of a section of wall to the rear of the property. The lane to the rear does form part of the public realm and the works proposed will alter the appearance of the site in its surroundings. The work will not, however, result in the unacceptable loss of a section of wall and will not have a significant impact on the character and appearance of the Conservation Area. It is also concluded that the work will not have a detrimental impact on the amenities of surrounding residents, especially as eleven out of the

sixteen properties in the terrace have made similar alterations to the rear of their properties.

The proposal to removal a section of rear boundary wall will improve vehicular access to the site enabling residents to better utilise the area of hardstanding available. It is concluded that the scheme meets the aims of Policy IP7 of the Island Development Plan.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
