NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Convert ground floor from shop to flat (Protected building).

LOCATION: 3 Tower Hill, St. Peter Port.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 17/10/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The property is three storeys set on the back edge of the footway to Tower Hill. It contains a shop, with shopfront, at ground floor level with two flats above.

To the east up the hill is a building converted to flats; to the west is a building of similar height and form incorporating a shop front at ground floor level.

3 Tower Hill is a protected building located in a conservation area. The property is located within the St Peter Port Main Centre and Conservation Area as defined in the Island Development Plan.

Conclusion/Brief comment:

This application is for a change of use of the ground floor from a retail unit to a one-bedroom flat.

The principle of conversion of the ground floor to an additional unit of accommodation is acceptable in policy terms and it is noted that permission was granted under the Urban Area Plan for the formation of a flat on the ground floor.

Policies GP4 & GP5 reflect the statutory duty to preserve and enhance the special quality of the character and appearance of the surrounding Conservation Area and the special interest and setting of Protected Buildings.

The proposed works involve some internal alterations and minor changes to the exterior of the building. There would be no significant effect on the fabric of the building, and the special interest of the protected building will be preserved. The proposed changes are not considered to have any impacts on the Conservation Area, as the external changes are minimal.

The amenity of the flat would be limited, only just within the minimal space standards specified in Part G of the Guernsey Technical Standards, with limited light and ventilation and no parking or outdoor amenity space. However, the property lies within the Main Centre of St Peter Port, where all amenities are within close proximity and the flat will sustainably located.

Although there is no parking, there are public car parks and good transport services close by. The proposed changes are not considered to impact on any neighbour amenity and there are similar units of accommodation within the area.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions. Although the standard of amenity enjoyed by the occupants would be limited, on balance, it is considered that finding a new use for this protected building over-rides those concerns.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
