NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Demolish chimneys, erect 2 storey extension to south (side) elevation, alter roof form to garage to north (side) elevation, erect covered area to front and rear elevations, install flue, external insulating render system and cladding and alterations to fenestration.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 17/10/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Le Menage' is a mid-20th century large detached two storey hipped roof dwelling, which is set far back from and faces west onto Rue Poudreuse, there is a driveway and front garden between the dwelling and the road and a large rear garden to the east. Other, large detached residential properties are situated to the north and south of the site.

The property is located Outside of the Centres as defined in the Island Development Plan.

Conclusion/Brief comment:

This application is to demolish both chimneys, erect a two-storey extension to south/side elevation, alter the roof form of the existing garage to the north/side elevation, to erect a covered area to front and rear elevations of the property and to install a flue, an external insulating render system and cladding along with alterations to fenestration.

This application has been submitted following the grant of permission to demolish the existing and erect a new dwelling. The replacement dwelling was a modern two storey box, whereas the current proposals are looking to keep the majority of the existing dwelling and remodel, which is a much more sustainable option.

The proposed elevations show a pitched roof modern example of the existing structure, with a two-storey extension to the south side, which is considered to fit comfortably into the surrounding area and would not impact on the character of the area. There would be no issues of overlooking due to distance, the height of, and mature nature of the boundary treatments. Overall the proposals are not considered to have any significant impacts on the amenities of adjoining properties.

The proposals achieve a good standard of design, using materials which complement the existing materials. The extensions and alterations proposed will provide adequate levels of sunshine and daylight and give the occupiers more flexible and adaptable accommodation.

There are to be no changes to the main vehicular entrance to the property and the majority of all landscaping will be retained.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
