NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect single storey extension and install cladding to south (rear) elevation and alteration to create additional parking area.

LOCATION: No 4 Clos D'Elise, Rue De La Cache, St. Andrew.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 03/11/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The application site comprises a detached, two storey dwelling-house located to the east of Clos D'Elise. The property is served by car parking to the front (north) and a garden to the side and rear. Beyond the rear garden lies Rohais De Haut.

The property is located Outside of the Centres as designated in the Island Development Plan.

Planning permission is sought to erect a single storey flat roof extension and install horizontal cladding to the rear elevation of the original dwelling and the extension. It is also proposed to alter the front garden in order to create additional car parking.

Conclusion/Brief comment:

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.

The proposed extension is modest in size and adopts a good standard of design for the purposes of Policy GP8, by virtue of its scale, form and mass. Whilst the thickness of the fascia is large, the overall design of the extension would be compliant with Policy GP8 and GP13.

Despite the lack of detailing submitted, the use of horizontal boarded cladding would not pose any significant issue given that the site does not affect a protected building, Conservation Area, nor is it sited prominently within the street scene.

The proposed flat roof extension would extend the rear building line of the property, would fall within the rear building line of properties to the south of Clos D'Elise and therefore would not affect the character of the area.

Due to the mature landscaping along the south boundary of the property, the proposal will not be highly visible in public vantage points and coupled with its design, there would be no significant adverse effect on visual amenity, or be over-dependent on the boundary treatment to screen the development.

Despite full length glazing on the east elevation of the proposed extension and being in close proximity to the east boundary, the proposal would not adversely affect the amenities of neighbouring residents when taking into account the relationship to the neighbouring property to the east, known as Palm Springs.

The creation of additional car parking to the front of the house will have a negligible effect on the character and appearance of the Clos and is considered a reasonable aspiration of the property owner (Policy GP13) given that a proportion of garden would remain, and that the property is served by a garage and one car parking space.

Sufficient information has been submitted that has taken into account the criteria of Policy GP9 (Sustainable Development).

Based on the above, the application is considered compliant with the relevant Island Development Plan policies; it is therefore recommended that planning permission be granted, subject to conditions.
