NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variation to previously approved plans to erect 1.5 storey extension with dormer window and balconies to north elevation (rear) and install rooflights to west (side) elevation - reconstruct dormers to front elevation.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun on or before 06/09/2022.

Reason - This condition reflects section 18(1) of the Land Planning and Development

(Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

4.The permission hereby granted relates only to the variation specified above. In all other respects the development shall be carried out in full accordance with the permission dated 06/09/2022, issued under planning application reference FULL/2022/1331, and subject to the terms and conditions thereof.

Reason - To limit the effect of the permission to the specified variation/s only.

Expiry Date: This permission will cease to have effect on 05/09/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Petit Monceau' is a pre-1900's one and a half storey traditional dwelling which has previously had a modern rear extension built. The dwelling is set back from and faces south onto Rue des Deslisles. There is a close neighbour to the west and the grounds of a Protected Building to the east and open land across the road to the south. The property is located Outside of the Centres and within the Agriculture Priority Area as defined in the Island Development Plan.

Relevant History:

FULL/2022/1331 - Erect 1.5 storey extension with dormer window and balconies to north elevation (rear) and install rooflights to west (side) elevation – Approved September 2022.

FULL/2019/0634 - Variation to plans previously approved to extend dwelling on rear (north) elevation, alterations to fenestration on south elevation - Increase floor area and install rooflights to rear (north) extension and infill section of window to front (south elevation) – Approve June 2019.

FULL/2018/2191 - Extend dwelling on rear (north) elevation, alterations to fenestration on south elevation and alter driveway to create additional parking – Approved October 2018.

Conclusion/Brief comment:

This application is for a variation to the previously approved application FULL/2022/1331, to erect a one and a half storey rear extension with large dormer window and balconies, etc. This variation is to reconstruct the front three dormer windows, inserting larger windows and thermally improving the sides and roof of the dormers.

Initially the changes to the dormers were asked for as a minor amendment, but they changes were considered more than minor and so a variation has been submitted.

Whilst the dormers appear larger than the existing dormers, this is due to the thermal upgrades proposed and, when visiting the site and looking at some of the neighbouring properties which also have similar dormers, the proposals would be consistent with the surrounding development, as well as providing sustainable improvements.

The proposals are considered to achieve a good standard of design, using materials which complement the existing materials. The dormers will now provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

The scale and massing of the new dormers are not considered to have a detrimental effect on the character and amenity of the surrounding area, nor will they have any impact on either of the immediate neighbours.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
