NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Excavate and erect retaining wall to extend parking area.

LOCATION: Wistaria, St. John's Road, St. Peter Port.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter

period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 31/07/2026 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Wisteria' is a large detached early 20th century dwelling which is set in the southwest corner of a large site facing northeast. The vehicular access is from the corner of St John's Road at the northern tip of the site. To the northwest, northeast and southeast are neighbouring properties and to the southwest a wooded area at a higher level which is the back of Beau Sejour. The wooded land is classed as Important Open Land and is an Area of Biodiversity Importance. The property is located in the St Peter Port Main Centre Outer Area and Conservation Area as defined in the Island Development Plan.

Conclusion/Brief comment:

This application is to excavate and erect a retaining wall to extend the parking area. At present the driveway comes from the road and sweeps around in front of the northeast front elevation, the proposals show the drive continuing to run parallel with the northeast boundary up past the northeast side elevation to a higher parking level at the rear of the property.

The front of the building shows a three and a half storey dwelling whereas at the rear of the building, due to the topography of the land, the back shows a two and a half storey building. There are a few meters of level ground at the rear of the property before it starts to rise steeply up to the southwest.

The proposals will actually replace a driveway from the 1970's, shown on the 1979 aerial photo. The reason for the additional parking is for the occupiers to be able to live on one level of the property. At present there is an external pair of staircases up to the front door, which will become a hindrance in the occupiers later years.

Although the proposals do excavate a fair amount of flora, including a few trees, there will be plenty of flora & trees left over a distance of 10m to the southwest boundary, meaning that what is to be removed does not warrant a refusal.

The proposals will not be seen from any public vantage points and are not considered to have any detrimental impacts on the special character and appearance of the surrounding Conservation Area, the Area of Biodiversity Importance, or on the Important Open Land, nor will the works impact any neighbour amenity.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
