NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect 1 1/2 storey detached garage/hobby room/store to south boundary (Protected Building).

LOCATION: Eureka, Rue Robin, Bordeaux, Vale.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 22/11/2026 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any

other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Eureka' is a pre-1900 detached one and a half storey dwelling, which sits along the west boundary on a corner site. Rue Robin runs along the north boundary, round and along the east boundary, There are other detached residential properties to the west and south. The property is set back from and faces north onto Rue Robin and the vehicle entrance is in the southeast corner. The property is located Outside of the Centres and within the Bordeaux areas defined in the Island Development Plan.

FULL/2023/1522 - Erect single storey extension to create dower unit to east (side) elevation. (Protected Building) – Pending.

FULL/2023/1502 - Erect single storey extension to south (rear) elevation (Protected Building) – Pending.

FULL/2018/1949 - Erect extension to side of dwelling (Protected Building) – Approved November 2018.

Conclusion/Brief comment:

This application is to erect a one and a half storey timber clad double garage and store/hobby room above, access by an external staircase. Initially the structure also had a single storey open car port added onto the south side of the garage, however, the size and scale of the proposal was considered to be too big for the size and scale of the property, plus it was not considered to contribute to the character and appearance of the surrounding conservation area.

The application was deferred for a number of reasons; the scale of the structure, the relationship between the garage and the main dwelling and the level of hardstanding in front of the garage.

An amended drawing has now been submitted which mitigates the majority of concerns. The single storey car port has been removed and the ridge of the garage has been lowered, reducing the scale so the garage is now subservient to the main dwelling. The block plan now shows the amount of hard landscaping between the entrance and the proposed garage, and shows a pathway to the rear of the property.

Although there are not many detached garages in the area which are timber clad, they are prevalent across the island, and because the scale of this one has been reduced and is now subservient to the main dwelling the garage is now, on balance, considered to comply with GP4 and GP5, the garage will not have any impacts on the setting of the protected building.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
