NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variation to plans previously approved to demolish existing flat roof extensions and outbuildings and extend dwelling - Raise roof ridge height to create additional floor area at 1st floor level.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of the original permission, see condition 4.

Reason - This condition reflects section 18(1) of the Land Planning and Development

(Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

4.The permission hereby granted relates only to the variation specified above. In all other respects the development shall be carried out in full accordance with the permission dated 07/11/2022, issued under planning application reference FULL/2022/1167, and subject to the terms and conditions thereof.

Reason - To limit the effect of the permission to the specified variation/s only.

Expiry Date: This permission will cease to have effect on 06/11/2025 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Les Vicheris' is a mid-20th century bungalow and outbuilding located in the northeast corner of the site. The property is set back from and faces east onto Rue des Vicheris. The site is part domestic curtilage and part agricultural land, and is surrounded by open fields which are part of a Site of Special Significance. The nearest neighbours are 80m away to the south, and 98m to the north. The property is located Outside of the Centres as defined in the Island Development Plan.

Relevant History:

FULL/2022/1167 - Change of use of agricultural land to domestic garden (300 sqm), demolish existing flat roof extensions and outbuildings and extend dwelling, remove hedge, erect garage and alter existing vehicle access (revised scheme) – Approved November 2022.

Conclusion/Brief comment:

This application is a variation to the previously approved application FULL/2022/1167, the variation is to raise the main dwelling ridge height by 690mm to create a first floor level, with single 740mm x 1400mm roof lights to the north and south roof slopes and four 660mm x 980mm roof lights on the east roof slope and large rear dormer window on the west elevation.

The raising of the ridge and the rear dormer are not considered to have any detrimental impacts on the character or appearance of the surrounding area, nor will they have any adverse impacts on neighbour amenity due to the distance between neighbours.

The addition of additional roof lights to the front elevation and both side elevations of the main dwelling are not considered to have any detrimental impacts to the character and appearance of the surrounding area, nor will they have any impacts on any neighbours as they are too far away.

The changes are not considered to impact the surrounding Sites of Special Significance which surround the site.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The design proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
