NOTIFICATION OF GRANT OF PLANNING PERMISSION

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 06/12/2026 unless development is commenced by that date.

The Authority does not recognise all of the land outlined on the submitted plans as forming the domestic curtilage associated with the dwelling presently known as Le Corvalet.

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

OFFICER'S REPORT

Brief Description of the site:

Planning permission is requested to erect an extension to form an entrance to the dwelling, install 2 rooflights to the north-west elevation and replace central rooflight with a zinc standing seam barrel roof and 3 rooflights. The extension to form the entrance would be constructed in granite with a grey membrane flat roof.

The application property comprises of an isolated detached house with a detached garage and shed. The dwelling is partially buried and is covered by earth. The site is located on the south coast cliffs at the end of a long gravelled track which links sections of the cliff path and it is surrounded by open and undeveloped land.

The property is located Outside of the Centres and is surrounded by a Site of Special Significance as designated under the Island Development Plan.

Relevant History:

21/08/2023 – FULL/2023/1255 – Permission granted to erect single storey garage/home office to west boundary.

29/03/2023 – FULL/2023/0074 – Permission granted to raise and alter roof to create accommodation at first floor (upper floor) level, erect extension and install rooflight to north-west elevation.

07/01/2019 – FULL/2018/2734 – Permission granted to widen existing driveway and install granite pillars and entrance gate. Clad side and rear walls of garage in granite.

Conclusion/Brief comment:

Planning permission was granted to raise and alter the roof to create accommodation at first floor level in March 2023 (FULL/2023/0074). This current application is for a revised scheme which omits the first floor level accommodation and instead involves replacing the existing central rooflight with a zinc standing seam barrel roof and 3 rooflights. The extension to form the entrance remains the same as the previously approved scheme.

The existing partially buried earth covered dwelling has been designed to minimise its visual impact within the landscape. The proposal to replace the central rooflight with a solid roof and rooflights of increased height and an above ground entrance would move away from the original design concept of the dwelling and would increase the visibility of the building within the landscape.

However, by virtue of its siting and relatively modest scale, together with the well-established planting within and around the site, the extended dwelling would not form an overly prominent feature from public viewpoints and it would have a reduced impact than the scheme approved in March 2023. The extensions and alterations achieve a good standard of design and the proposal is unlikely to have any significant adverse effects on the landscape character and openness of the area, in accordance with Policies GP1, GP8 and GP13.

The dwelling is surrounded by a Site of Special Significance. No works are proposed within the Site of Special Significance. To address comments raised on behalf of La Société Guernesiaise as part of the previously approved application in March 2023 regarding the potential impact of light pollution on wildlife, it is recommended that a note is attached to the decision notice to discourage or minimise the use of external lighting. The proposal is unlikely to have any adverse impacts on the adjoining Site of Special Significance.

To address the comments raised on behalf of La Société Guernesiaise as part of the previously approved application in March 2023, it is recommended that a note is attached to the decision notice to make the applicant aware of the potential issues with disturbing animals which are protected under the Animal Welfare Ordinance 2012.

Information has been submitted to demonstrate that the design has taken into account the use of energy and resources, in accordance with Policy GP9.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.

It is recommended that the application is approved.
