NOTIFICATION OF GRANT OF PLANNING PERMISSION

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 19/12/2026 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any

other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

Other Remarks:

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

This document is not a Building Licence and confers no approval under the Building Regulations.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The application relates to the replacement of two windows to the north (rear) and west (side) elevations of Les Adams farmhouse.

The site is located Outside the Centre as designated in the Island Development Plan. The property is a Protected Building and is pre-1900s.

Relevant History:

FULL/2022/2213 – Demolish and rebuild chimney, re-roof and install rooflights to north roof slope. Erect extensions at 1st floor to north (rear) and flat roof extension

FULL/2022/2229 – Install replacement windows to north (rear) and alterations to window to west (side) elevation (Protected Building).

Policies considered most relevant:

The whole of Les Adams is protected together with a large number of boundary walls and features and the interior and exterior of all outbuildings including the cider-making machinery.

It is proposed to replace a timber vertical sliding sash window in the north gable of the back kitchen. This unit dates to c.1980 and makes a neutral contribution to the special interest. Its replacement as proposed – large-scale drawings are provided – meets GP5 and CN11.

It is also proposed to remove a timber vertical sliding sash window from the west elevation of the back kitchen. The window makes a positive contribution to special interest but is in a poor condition as a result of inappropriate detailing in relation to the adjacent roof and flashing. The opening would be repositioned and enlarged so as to remove this problem and a new window unit would be installed. This part of the building is of high value. Altering the position of the window opening would have a minor impact, the resultant effect on overall special interest being

slight/moderate (BS 7913:2013). In this instance, the alterations are a reasonable aspiration that outweighs the harm. The large-scale drawings provided are acceptable and so there is no conflict with Policy GP5.

Conclusion/Brief comment:

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
