NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Demolish existing extension, erect single storey extension at ground floor level and enlarge dormer windows to second floor level to east (rear) elevation.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development

(Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 27/12/2026 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any

other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Highfield' is a two and a half storey pre-1900's dwelling from the front and a three and a half storey dwelling from the rear. The property is set back from and faces west onto La Route de Sausmarez, there are other residential properties to the north and across the road to the west, and a detached Protected Building within extensive grounds to the south and east. The property is located Outside of the Centres and within a Conservation Area as defined in the Island Development Plan.

There is no relevant history pertaining to this application.

Conclusion/Brief comment:

Demolish the existing rear square hipped extension and replace it with a slightly larger rectangular hipped with central rooflight extension in the same location to house a new kitchen. Plus, extend the two rear bedroom dormers on the east roof slope.

The existing rear extension was added in the 1980's and is not considered to have any particular architectural importance, so its removal would not have any adverse impacts. Furthermore, it cannot be seen from any public vantage points. The replacement will be a little larger with bi-fold doors along the south and east elevations giving additional light and allowing for indoor/outdoor living.

The dormer windows are far enough away from the boundaries of the site to prevent any overlooking, they are at the rear of the property and cannot be seen from any public vantage points. The rear elevation of the property has been changed significantly over the years so that it has lost most of the original architectural elements and proportions, therefore allowing the dormer windows to increase is not considered to have any detrimental impacts on the special quality of the character and appearance of the surrounding conservation area, and nor will they have any impact on either of the immediate neighbours. None of the proposals will have any impacts on the setting of the adjacent Protected Building.

The proposals achieve a good standard of design, using materials which complement the existing materials. They will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
