NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect first floor extension to east (rear) elevation (Revised).

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter

period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 10/01/2027 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. OFFICER'S REPORT

Brief Description of the site:

The property known as 'L'Etacq' is a mid-terrace pre-1900 one and a half storey dwelling which is set back from and faces west onto Sandy Lane. The attached neighbours are to the north and south and there are detached neighbours to the east beyond the garden and west across the road. The property is located in the L'Islet Local Centre as defined in the Island Development Plan.

FULL/2023/1504 - Erect extension at 1st floor level to east (rear) elevation – Refused October 2023.

Conclusion/Brief comment:

This application is a revised application to erect a first floor extension to the east/rear elevation. The changes are a pitched, hipped roof rather than a flat roof, the omission of the roof lanterns and the size (length) of the extension has been reduced by just over 1m.

There is still one first floor bedroom which does not have a regular window, it does have two high level roof lights, but this is an improvement from the previously refused application where there were two rooms without regular windows. A

protected lobby will be created on the ground floor to allow for safe egress in the event of a fire.

The bedroom is a single occupancy room, which is part of a dwelling with primary living accommodation across the ground floor and access to external amenity space. Although the outlook from the bedroom with rooflights is not ideal, this alone would not be sufficient to withhold planning permission in this case.

Therefore the proposals are now considered to achieve a good standard of design, using materials which complement the existing materials. The extension will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

The scale and massing of the new extension is not considered to have a detrimental effect on the character and amenity of the surrounding area. The location of the east facing first floor window is not considered to have any detrimental impacts on overlooking the neighbours because the window is now located further forward, which means there are no longer views onto the neighbours private amenity spaces.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
