NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Raise and alter roof form to create accommodation at 1st floor level, extend and alter at ground floor level and erect single storey detached outbuilding to south-east boundary.

LOCATION: Le Pins De Bas, Route De Cobo, Castel.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1. All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 11/04/2027 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Le Pins de Bas' is a detached mid-20th century bungalow which is set back from and faces southwest onto Route de Cobo. There are neighbouring properties to the northwest and southeast, and across the road to the southwest. There is also a neighbour to the northeast beyond the garden. The property is located Outside of the Centres as defined in the Island Development Plan (IDP).

Representations:

There has been one letter of representation has been received and the planning issues are:

'Given that the cover letter already provides a thorough explanation of how the proposed development aligns with the strategic objectives of the Island Development Plan. I would simply add that their decision to use natural stone cladding enhances the character of the area and their efforts to make their property more energy efficient by using double glazed windows in line with GP 8 is commendable.'

Therefore, I fully support the landowner's decision to raise and alter roof form to create accommodation at 1st floor level, extend and alter at ground floor level and erect single storey detached outbuilding to southeast boundary and wish for it to be approved without delay.'

Conclusion/Brief comment:

This application is to raise and alter the roof form to create first floor accommodation, remove existing rear extensions and erect a single storey flat roof extension across the whole of the rear elevation. Finally replace the existing single garage with a new flat roof single garage in a similar location.

The site is located along one of the main routes to Cobo bay, which is characterised by a mix of mid-20th century, with a few modern one interspersed, meaning there is no dominant form or style to the built form.

The houses on either side of Le Pins de Bas are two storey and so raising the roof is not considered to have any detrimental impacts in the character of the area or on neighbour amenity because although the property will have first floor windows for the first time, the distance and oblique nature between the buildings means there is little opportunity for overlooking.

The IDP supports multi-level living as it constitutes a more efficient use of land than single storey buildings. Therefore a minimal amount of first floor overlooking is not considered to be so bad as to warrant a refusal.

The proposals achieve a good standard of design, using materials which complement the existing materials. The scale and massing of the new extension is not considered to have a detrimental effect on the character and amenity of the surrounding area. The extension will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
