NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Demolish chimney, erect single storey extension to east (rear) elevation, alterations to fenestration. Erect fence and wall, create gated pedestrian accesses to north and west and vehicle access to west boundary.

Conditions and reasons:-

1. All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 12/06/2027 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. Brief Description of the site:

The property known as 'New Haven' is a mid-20th century bungalow which sit in the middle of a corner plot and faces west onto Sandy Lane, Kimberley Avenue runs along the north boundary and there is an unused track along the east boundary and a neighbouring property to the south. The property is located Outside of the Centres as defined in the Island Development Plan.

Conclusion/Brief comment:

This application is to demolish the chimney (which is exempt), erect a single storey conservatory to the rear east elevation and some alterations to the fenestration. Plus erect a fence to the east and south boundaries and a 900mm high rendered wall with openings along the west and north boundaries (the wall is exempt, but the new vehicular opening does require planning permission).

The conservatory although at the rear of the property still faces a highway, as a track is included in the description of a highway. The windows of the conservatory will also be within 3m of a boundary, these are the two reasons why the conservatory extension is not exempt.

However, the new 1.8m high fence will screen any views from the windows into the neighbour's garden. The track has obviously not been used as a track for many years, in fact there is an abandoned car blocking the way and the flora is flourishing. Therefore the concerns about the extension being forwards of the rear building line are mitigated and the conservatory is not considered to have any impacts on the character or the area or on neighbour amenity.

The minor alterations to the fenestration are considered appropriate and acceptable.

Initially the proposal showed a new vehicular entrance on the west boundary straight onto Sandy Hook, which is the busier road, and the entrance would be right next to the junction with Kimberley Avenue. It is known that new entrances right next to a junction are not often supported because there are traffic safety issues when indicating. The application was deferred and the proposed new access was moved to the north boundary onto Kimberley Avenue.

Kimberley Avenue is not a through road and serves 28 properties, the addition of one extra property would not affect the traffic flows and therefore a new entrance onto this road, albeit still close to the junction, is not considered to have as many traffic safety issues as previously proposed, as the main concern would be from the oncoming traffic, which would be slowing down as they reach the junction.

The proposed fence along the eastern boundary has been stepped down in front of the building line, with the last fence panel lowered to 900mm, to allow for better sight lines for vehicle users. The fence is considered to comply with policy.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
