NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variation to previously approved plans to extend and alter dwelling to south (side) elevation and erect outbuilding to south-west boundary - increase floor area at ground floor level to east (rear) elevation, reduce dormer window to west elevation, omit flue and alterations to fenestration.

Conditions and reasons:-

1. All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 16/08/2027 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Site Description:

The property known as 'Horizon' is a one and a half storey semi-detached dwelling with a steep roof slope, which matches the other five houses around the Clos. The house faces southwest onto the end of Clos D'Albecq, the attached dwelling and one other are to the north, one to the south facing north and the last two to the west facing east. Directly to the east and south is another residential development, Pine Grove. The property is located Outside of the Centres as defined in the Island Development Plan.

Relevant History:

FULL/2021/0279 - Extend and alter dwelling to south (side) elevation and erect outbuilding to south-west boundary – Approved August 2021.

Existing Use(s):

Residential use class 1: dwelling house.

Brief Description of Development:

This application is a variation to the previously approved FULL/2021/0279, the variation is to increase the ground floor area by adding a rear single storey flat roof extension, reduce the size of the west facing front dormer window, omit the flue and some alterations to the fenestration.

Relevant Policies of any Plan, Subject Plan or Local Planning Brief:

GP8: Design

GP9: Sustainable Development

GP13: Householder Development

Representations:

There has been one letter of representation and the issues are:

'We live adjacent to the proposed extension submitted by Mr. & Mrs. Nick Bougourd, of Horizon, Clos D' Albecq, Castel. If the planning permission is approved and the extension is built, we feel that it would have a detrimental effect on all the adjoining properties, in particular but not limited to: -

- 1) Rosenborg, 1 Pine Grove - back of house would be completely overlooked and the garden will be in the shade most of the day*
- 2) 6 Pine Grove- view from property would be substantially reduced*

As far as we know, previous applications to extend above a garage in Clos D' Albecq have been declined in the past, presumably because this would totally change the outline of these unique houses. We would expect this one to follow the same path.'

Summary of Issues:

- Design of the development.

Assessment against:

1 - Purposes of the law.

The objectives of the Law, as set out in Section 1(2), have been considered and this forms part of the assessment of policy issues as set out in 2 below.

2 - Relevant policies of any Plan, Subject Plan or Local Planning Brief.

The west facing dormer window looks over the clos and the front 'non-private' gardens of the clos dwellings, the reduction of the dormer is considered acceptable and appropriate. the other window changes are the addition of a high level round window on the west elevation and changing the existing rear garage window to a set of sliding doors, both of which are considered to comply with policy.

The proposed ground floor extension is considered to achieve a good standard of design, using materials which complement the existing materials. The extension will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

The scale and massing of the new extension is not considered to have a detrimental effect on the character and amenity of the surrounding area, nor will it have any impact on either of the immediate neighbours.

The letter of representation seems to be referring to the previously approved extension over the garage, which is not part of this application to be assessed and therefore the comments cannot be taken into consideration as they are not relevant to the proposed scheme.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

3 - General material considerations set out in the General Provisions Ordinance.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application. Where relevant the issues are considered in section 2 above.

The proposal would have no impact on Protected Buildings, Trees or Monuments or on SSS's.
