NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Remove hedge and erect fence to south-east boundary.

LOCATION: Hidden Gem, Bouillon Lane, St. Peter Port.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 07/02/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

This document is not a Building Licence and confers no approval under the Building Regulations.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Hidden Gem' is a late 1970's bungalow which is set back from and faces northeast onto Bouillon Lane, to the northwest/west is a row of garages, to the southwest and south are residential neighbours which face southwest onto Les Amballes and to the southeast are the rear gardens of the southern neighbours, the boundary of the neighbours gardens with Bouillon Lane is a 2m high granite wall and the boundary from the garages with Bouillon Lane is a 2.7m high granite wall. The property is located in the St Peter Port Main Centre Outer Area as defined in the Island Development Plan.

There is no relevant history pertaining to this application.

Conclusion/Brief comment:

This application is to remove a dying hedge along the northern end of the southeast boundary and to replace it with a 1.8m high fence (composite with oak finish/colouring).

The hedge has been dying off for some time, but the property also had a number of bushes in front of the hedge, which have now been removed, leaving a boundary full of gaps. The neighbour had put up a temporary boundary made from pallets, these will be removed once the fence is installed.

Much of the southwest side of Bouillon Lane is made up of a high granite wall, apart from where properties have been introduced and the walls have been either been reduced in height or removed.

Essentially the southeast side of the lane has the character of high walls, and so introducing a 1.8m high fence to one side of the property up to the road would result in less harm than in a road with a more open character. The fence would not be seen when approaching from the southeast and it would only be glimpsed when approaching from the northwest. In this instance the height of the fence forward of the building line would not cause undue concern. It would not have an unacceptable adverse impact on the character of the area and would provide privacy to the neighbouring garden area.

Although timber fencing may be more appropriate in the Conservation Area setting it is noted that the current planning exemptions allow for the use of composite materials for fencing (including within Conservation Areas) and there would not be sufficient grounds on which to withhold permission.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
