NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Alterations to fenestration of main dwelling. Erect single storey outbuilding, relocate oil tank and existing shed and wall to east (rear) of property.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 09/01/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Latgale' is a mid-20th century bungalow which is set back from and faces west onto Helston Estate. There are neighbouring properties to the north and south and across the road to the west. Directly to the east is a road which services two properties. The property is located Outside of the Centres as defined in the Island Development Plan.

Conclusion/Brief comment:

This application is for alterations to fenestration in the main dwelling, to erect a single storey mono-pitch timber outbuilding along the east boundary as well as relocating one of the sheds to the northeast corner of the garden and relocating the oil tank to the southeast corner of the rear garden. A second shed is to be removed.

The majority of changes to the fenestration are exempt. The change in one window (north elevation), close to the boundary with the neighbouring property that requires planning approval. The window is not a new opening, the window proportions are shown to alter, so the opportunity for overlooking is the same as the previous window and therefore there are no concerns with the change.

The outbuilding, relocation of the oil tank and shed only require planning approval due to the road running along the east site boundary. This road serves two

properties and the boundary treatment running along this boundary comprises a 1.5m high rendered wall with a 0.7m high fence above. On Latgales side of the boundary, the top of the fence is 1.9m due to a slightly higher ground level.

As there is a high boundary along the length of the driveway road east of the property, which would screen the proposals, and the fact that the east facing garden of Latgale is considered to be their private amenity area, the proposals are therefore considered to be appropriate and acceptable.

The proposals achieve a good standard of design. The outbuilding will provide adequate levels of sunshine and daylight and give the occupiers more flexible and adaptable accommodation. The scale and massing of the new outbuilding is not considered to have a detrimental effect on the character and amenity of the surrounding area, nor will it have any impact on any of the immediate neighbours.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
