NOTIFICATION OF GRANT OF PLANNING PERMISSION

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter

period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 07/04/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

For the avoidance of doubt, the advertisement(s) to which this permission relates are non-illuminated. Any form of illumination, whether by external or internal means, will require a separate grant of planning permission.

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. OFFICER'S REPORT

Brief Description of the site:

The now 'Morrisons Daily' (formerly an Iceland) is located on the north side of Route de Carteret, to the west of the shop is the car park and then the coast road, Rue de la Saline. To the north and east are residential dwellings. The property is located in the Cobo Local Centre as defined in the Island Development Plan.

'I have concerns that the illuminated signage may have an impact on the amenity of residents living close to the site. I would therefore recommend that the following conditions are attached to any consent granted for this application:

- *The hours of operation for the exterior illuminated signage shall be limited to 06:00 to 22:00 each day.*
- *The exterior illuminated signage shall be operated by a timer which is set to illuminate and extinguish lighting at the permitted times.*

Conclusion/Brief comment:

This is a retrospective application to erect signs and illuminated signs to the south elevation and an illuminated sign to the west elevation.

Initially the candelas per square metre were 250cd/sqm, which was considered far too light for the Island in general and especially for this location as it is so close to the coast and residential properties. In this instance it was considered that any lighting would cause unnecessary light pollution and so the application was deferred to request that the illumination was removed from the signs. The agent has agreed to remove the lighting from this application and revised plans have been submitted.

Policy LC5 states that limited works to alter, extend or redevelop existing convenience retail outlets will be supported provided that the proposals are of appropriate scale for the particular Local Centre and would not undermine the vitality of the Main Centres and will accord with all other relevant policies of the Island Development Plan.

The proposals intend to up-date the existing shop entrance with some new signage. The signs at this location are not to be illuminated, and the proposals are not considered to have any detrimental impacts on any residential neighbours.

The proposals are not considered to impact on the character and appearance of the surrounding area and therefore are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
