NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variation to previously approved plans to raise, extend and alter roof ridge height at second floor level, extend and alter at ground floor level and first floor level to east (side) elevation and alterations to fenestration - Raise ridge height by 520mm, omit balcony to south elevation and alterations to fenestration.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun on or before 14/10/2027.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission). In this case, as the application is for variations, the time period corresponds with the original permission under application reference FULL/2024/1543.

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

4. The permission hereby granted relates only to the variation specified above. In all other respects the development shall be carried out in full accordance with the permission dated 14/10/2024, issued under planning application reference FULL/2024/1543, and subject to the terms and conditions thereof.

Reason - To limit the effect of the permission to the specified variation/s only.

Expiry Date: This permission will cease to have effect on 14/10/2027 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'La Cloche' is a late Victorian two storey dwelling, which has been added to over the years. The dwelling is located to the south-east of Les Traudes which runs from the north to the west of the dwelling in a diagonal, the vehicular entrance and parking area for La Cloche are situated to the north of the dwelling. There are gardens to the west and immediate south of the property. To the east is agricultural land in the form of open fields. The property is located Outside of the Centres and is with the Agriculture Priority Areas (APA) defined in the Island Development Plan.

Relevant History:

FULL/2024/1543 - Raise, extend and alter roof ridge height at second floor level, extend and alter at ground floor and first floor level to east (side) elevation and alterations to fenestration – Approved October 2024.

FULL/2024/0725 - Raise roof ridge. Extend and alter at 2nd floor level including balcony to south (rear) and alterations to 1st floor fenestration – Approved May 2024.

FULL/2022/1784 - Extend and alter at 2nd floor level to east (side) elevation – Approved November 2022.

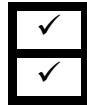

Conclusion/Brief comment:

This application is for some variations to the previously approved application FULL/2024/1543 and comprises raising another section of roof so that it is all at the same level to simplify construction, remove the first floor balcony and alterations to the fenestration of the building.

The changes to the fenestration are considered acceptable as they revert back to the existing openings on the ground floor, and are relatively small changes on the first and second floors.

Removing the south elevation first floor balcony is also considered appropriate and acceptable.

Raising the last section of roof to match the rest of the raised roof line is not considered to have any further impacts on the character and appearance of the surrounding area nor will the proposals have any adverse effects on neighbour amenity.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
