NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variations to works previously approved to extend at first floor level and raise roof height to create accommodation at second floor level for unit 2 - create a roof terrace at 3rd floor level with a glazed covered access.

LOCATION: Apartment 2, 7 Berthelot Street, St. Peter Port.

APPLICANT: Stone House Properties Ltd

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun on or before 13/06/2026.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission). In this case, as the application is for variations, the time period corresponds with the original permission under application reference FULL/2022/2095.

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

4. No development shall begin on site until details of the covered access, including 1:20 elevations and details of the materials of the frame and glazing, have been submitted to and agreed in writing by the Authority. The development shall be carried out only in accordance with the agreed details.

Reason - The information provided with the application does not include full details of the proposed covered access. This condition is imposed to make sure that the design of the development does not have any adverse impact on the character and appearance of the Conservation Area.

5. The permission hereby granted relates only to the variations specified above. In all other respects the development shall be carried out in full accordance with the permission dated 14/06/2023, issued under planning application reference FULL/2022/2095, and subject to the terms and conditions thereof.

Reason - To limit the effect of the permission to the specified variations only.

Expiry Date: This permission will cease to have effect on 13/06/2026 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

Copy of representations made:

In reaching this decision the Authority took into account any written consultations made under Section 11(1) of the Land Planning and Development (General Provisions) Ordinance, 2007 ('the Ordinance'). A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

OFFICER'S REPORT

Brief Description of the site:

Planning permission is requested for variations to works previously approved to extend at first floor level and raise roof height to create accommodation at second floor level for unit 2 (FULL/2022/2095) and to create a roof terrace at third floor level (FULL/2024/0155). The variations involve erecting a glazed covered access to the third floor roof terrace.

The site consists of a traditional 2½ storey building fronting onto Berthelot Street and a series of modern one and two storey flat roof extensions to the rear. The section of the building which fronts onto Berthelot Street is an office with 2 flats within the modern rear extensions.

The site is within the St Peter Port Main Centre Inner Boundary and Conservation Area. The adjoining building to the east is a protected building.

Relevant History:

07/08/2024 - FULL/2024/0155 – Permission granted for variations to works previously approved to extend at first floor level and raise roof height to create accommodation at second floor level for unit 2 - create a roof terrace at 3rd floor level.

31/07/2024 – FULL/2024/0907 – Permission granted for variation to previously approved plans to extend at first floor level and raise roof height to create accommodation at second floor level of unit 2 and alterations to fenestration - Omit 1.8m obscured glazed balustrade and install 1.1m high railings (retrospective).

14/06/2023 – FULL/2022/2095 – Permission granted to extend at first floor level and raise roof height to create accommodation at second floor level for unit 2 and alterations to fenestration.

05/12/2018 – FULL/2018/2060 – Application refused to extend and alter building and change of use from office accommodation to two residential units with roof terrace/garden. Alterations to building include new parapet construction, first floor extension, glazed balustrades and apply external render system(Revised). Application subsequently approved at appeal 09/04/2019, PAP/001/2019.

22/05/2018 – FULL/2018/0534 – Permission granted to remove dormer window, demolish chimney, alter and replace fenestration, re-render external wall and install new folding/sliding access doors/gates to front of property. Alter fenestration to side (east) elevation and install three rooflights to rear (partially retrospective).

13/02/2018 – FULL/2017/2162 – Application refused to extend and alter building and change of use from office accommodation to two residential units with roof terrace/garden and office accommodation. Alterations to building include new parapet construction, first floor extension, installation of roof lights, alterations to fenestration, demolish chimney and dormer window and apply external render system (partially retrospective).

18/11/2011 – FULL/2011/2749 – Permission granted for the change of use of office accommodation to residential dwelling and office accommodation.

Conclusion/Brief comment:

Planning permission was granted in June 2023 to extend unit 2 at first floor level and to raise the ridge height to create accommodation at second floor level (FULL/2022/2095). Planning permission was subsequently granted in August 2024 to vary the permission to create a roof terrace at third floor level (FULL/2024/0155). This current application seeks to vary the previous permissions and proposes to create a glazed covered access to the third floor roof terrace.

The previously approved glazed balustrade around the roof terrace was restricted to a height of 1.1m in order to minimise its visibility within public views of the St Peter Port townscape. The proposed rooftop access would project above the balustrade and would be visible within public views, for example from Mignot Plateau. However, the roof access would be seen in context with surrounding roof forms and together with its modest scale and largely translucent nature and the distance at which it would be visible in public views, the proposal is likely to have a limited visual impact and will not be overly noticeable within public views of the St Peter Port townscape. The proposal would conserve the character and appearance of the Conservation Area, in accordance with Policy GP4. Further details of the design and materials of the covered access would be required, this can be dealt with by condition.

The erection of the covered roof access would have no additional adverse effects on the amenities of neighbouring residents.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.

It is recommended that the application is approved.
