NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect single storey building/garage and hardstanding/parking area to north-east boundary (Protected Building).

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 16/03/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any

other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Brief Description of the site:

The property known as 'Les Varioufs' is a two storey granite dwelling with a few outbuildings, all clustered into the northwest corner of the large site. Les Quatre Vents runs along the north boundary and the vehicular entrance is from this road, and Les Varioufs runs along the west boundary. To the south and across the road to the north are detached neighbouring properties and to the east and across the road to the west are open fields. The property is located Outside of the Centres as defined in the Island Development Plan. Les Varioufs is a Protected Buidling.

Relevant History:

FULL/2024/1906 - Demolish existing outbuilding, erect outbuilding/summerhouse to east of property (Site of a Protected Building) – Approved December 2024.

FULL/2024/1329 - Re-cladding of north and south elevations, alterations to fenestration (all elevations), demolish and erect garage to east elevation of domestic outbuilding – Approved September 2024

Conclusion/Brief comment:

This application is to erect a single storey three bay garage, which faces south, with a section of permeable brick paving outside the entrance. The garage will be located in the northeast corner of the site, close to the vehicular entrance.

The garage will be located away from the main dwelling on the other side of the vehicular entrance so it will not be read as part of the cluster of pre-1900's buildings. The garage will be close to the road and is not considered to impact on the open nature of the area.

The proposals achieve a good standard of design, using materials which complement the existing materials. The scale and massing of the new garage is not considered to have a detrimental impact on the special interest of the protected building or any detrimental effects on the character and amenity of the surrounding area, neither will it have any impact on any of the immediate neighbours.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
