NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variation to previously approved plans to erect single storey extension to north (rear) elevation, erect rooflight to east (side) elevation and alteration to fenestration, alter existing vehicle access to form gated vehicle and pedestrian access - Reduce size and alter roof material (omit green roof and recind conditions 4 and 5) to north elevation and alterations to fenestration.

LOCATION: De Beauvoir, Rue des Jehans, Torteval.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun on or before 02/01/2027.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

4.The permission hereby granted relates only to the variation specified above. In all other respects the development shall be carried out in full accordance with the permission dated 03/01/2024, issued under planning application reference FULL/2023/2380, and subject to the terms and conditions thereof.

Reason - To limit the effect of the permission to the specified variation/s only.

Expiry Date: This permission will cease to have effect on 02/01/2027 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER’S REPORT

Brief Description of the site:

De Beauvoir is a detached two-storey house with rooflights to the rear roofslope. It has a decorative front façade with slate roof and multi-pane sash windows whilst the rear elevation has exposed granite, a mix of casement and sash windows and a pantile roof. Various single-storey extensions have been constructed to the property, to the sides and rear. De Beauvoir occupies a plot on the junction of Rue Des Jehans and Rue De L’Eglise.

The site is located Outside of the Centres and within a Conservation Area as designated in the Island Development Plan.

Conclusion/Brief comment:

Permission has been granted to demolish the single-storey extensions to the rear of the dwelling and to construct an 'L' single-storey flat roof extension with associated rooflights and incorporating a sedum/green roof. Alterations to fenestration was also approved including a new rooflight and a ground floor window to the west elevation of the single-storey lean-to. In relation the vehicular access permission was granted to partially infill the existing to form a gated pedestrian gateway and a bin store and the demolition of an existing boundary wall to create a new vehicular access with associated gates, to the north of the dwelling.

This variation application relates to alterations to the position and reduction in the footprint of the approved extension with associated alterations to fenestration and the omission of the sedum/green roof, and so the omission of the associated planning conditions.

The single-storey extension as amended represents a high standard of design that respects the local built environment and will not result in harm to amenities of surrounding residential occupiers. The scheme offers occupiers with adequate daylight/sunlight and retains ample external amenity space to meet the needs of occupiers. The proposal offers more flexible and adaptable accommodation with access for all both within and around the building.

Conditions 4 and 5 related to details of, along with information relating to, management/maintenance of the proposed green roof and its provision within a specified timeframe. Although the omission of a green roof is regrettable in terms of the character and visual amenity of the Conservation Area its omission from the scheme will not result in the proposed single-storey flat roof extension being unacceptable in principle. As outlined above, the extension is still considered to represent a high standard of design and complies with the aims of Policies GP4, GP8, GP9 and GP13 of the IDP. The alterations to fenestration will not result in undue harm to the amenities and privacy of any surrounding residential neighbour.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
