NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect single storey extension to south elevation, demolish chimney, replace roof covering and install cladding to existing outbuilding/bunker.

LOCATION: Highlands, La Croix du Bois, Vale.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 07/04/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The application property comprises a c.mid-C20th bungalow with attached 1 ½ storey wing, positioned centrally on a large corner plot at the junction of La Croix du Bois and Route des Coutures. It is one of a number of dwellings clustered around the crossroads, 3 of which are protected buildings. The site adjoins agricultural land to the west, and is located Outside of the Centres in an otherwise non-designated area under the Island Development Plan.

Conclusion/Brief comment:

Policy GP13 is generally supportive of proposals for domestic extensions, alterations and other such householder development, unless material considerations indicate otherwise or conflicts with other Plan policies or the States strategic objectives are identified.

In this case the application proposes an extension to the existing bunker to form a pitched roof garage, along with alteration to the existing bunker, including the introduction of external composite cladding and a new GRP roof.

The German bunker was built after 1938 and is of little architectural or historical merit. The impact on the setting of the nearby protected buildings is reduced given that it is set at a lower level than the road and so less prominent.

The proposed extensions, alterations and use of cladding are acceptable given the direction to apply less prescriptive control over householder development in less sensitive areas established by Policy GP13. It is not considered that the proposed development would have any significant effect on the setting, or harm the special interest, of the nearby protected building. The application is therefore considered to accord with both the Law and the aims and objectives of policies GP5 and GP8.

As the cladding of the outbuilding itself would be exempt development, it is not considered appropriate or reasonable to condition the colour/type of composite cladding used.

Information has been submitted which demonstrates that sustainable development principles have been considered in developing this scheme, in accordance with the requirements of Policy GP9.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land and Planning (General Provisions) Ordinance 2007 have been taken into account in the assessment of this application.
