NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Erect shed to west boundary and erect fence to south boundary to alter parking area (west of dwelling), and erect fence to west/front of dwellinghouse (part-retrospective).

LOCATION: Kinallen, 6 Clos Des Petites Maisons, Vale Road, St. Sampson.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 28/04/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

Other Remarks:

Please contact Traffic & Highway Services (highways@gov.gg) for further advice. You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

This document is not a Building Licence and confers no approval under the Building Regulations.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

The property known as 'Kinallen' is a 1980's semi-detached bungalow, which is set back from and faces west onto Clos des Petite Maisons. The other semi is attached to the south and another pair of semi's are to the north, parking and the rear garden of the properties facing west onto Vale Road are to the west and there is a walkway and high granite wall to the east. The property is located in the St Sampson Main Centre Outer Area as defined in the Island Development Plan.

Relevant History:

FULL/2023/0585 – Demolish shed, install flue to north (side) elevation and alterations to fenestration, erect fence and shed to east boundary and fence and gate to north boundary – Approved June 2023.

The submission notes that the site to the north is the subject of development approved in 2022 (varied in 2024) for two dwellings.

Conclusion/Brief comment:

This application is to erect a shed to the west boundary of the parking area (across the road from the dwelling) and erect a fence to the south boundary delineate and alter the parking area.

As the fence is a post and wire fence it is not considered exempt even though it is 0.9m high. The installation of the fence has been undertaken and in this regard the

application is retrospective. Permission is also sought for the fence already erected along the north boundary of the main site, to the west of the front door of Kinallen.

In this case the shed will be located on the other side of the road to the house and will be nestled into a corner with a high granite wall behind it (to the west) and a 1.5m high boundary wall along the north side. As it is a relatively small shed the location is considered to be appropriate and acceptable because it would be screened by the walls when considering the character of the locality.

The proposals are not considered to have any detrimental impacts on the character and amenity of the surrounding area, nor will they have any adverse effects on any of the immediate neighbours.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
