NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Variations to previously approved plans to erect single storey detached garage/outbuilding to east of unit 3 - Reposition garage/outbuilding and enlarge floor area, alterations to external materials, fenestration and erect boundary wall to east boundary.

LOCATION: Kizomba, Les Canus, St. Sampson.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2. The development hereby permitted shall be begun on or before 10/09/2026.

Reason - This condition reflects section 18(1) of the Land Planning and Development

(Guernsey) Law, 2005 which states that planning permission ceases to have effect unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission). In this case, as the application is for variations, the time period corresponds with the original permission under application reference FULL/2023/1380.

3.The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

4.The permission hereby granted relates only to the variations specified above. In all other respects the development shall be carried out in full accordance with the permission dated 11/09/2023, issued under planning application reference FULL/2023/1380, and subject to the terms and conditions thereof.

Reason - To limit the effect of the permission to the specified variations only.

Expiry Date: This permission will cease to have effect on 10/09/2026 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. The official Appeal Notice Forms are available on the States of Guernsey website at www.gov.gg/planningpanel and must be completed with all enclosures in multiples as requested and received within the six months deadline.

Copy of representations made:

In reaching this decision the Authority took into account any written consultations made under Section 11(1) of the Land Planning and Development (General Provisions) Ordinance, 2007 ('the Ordinance'). A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

You must also ensure that any access/es to the development are constructed to meet the existing road/footway levels in accordance with their requirements.

A separate Building Control Licence may be required and it is the responsibility of the developer to ensure that ALL necessary consents are obtained and that any pre-commencement conditions are discharged prior to development being commenced.

OFFICER'S REPORT

Brief Description of the site:

Planning permission is requested for variations to previously approved plans to erect single storey detached garage/outbuilding to east of unit 3 (FULL/2023/1380). The variations include reposition garage/outbuilding and enlarge floor area, alterations to external materials and fenestration and erect boundary wall to east boundary.

The application site previously comprised a redundant vinery site, formerly known as Birklands Vinery, which is located to the south of Les Canus. Following the grant of planning permission to convert and extend the packing shed into 3 dwellings work has commenced on site and is now largely complete. The site is situated Outside of the Centres as designated in the Island Development Plan.

Relevant History:

11/09/2023 – FULL/2023/1380 – Permission granted to erect single storey detached garage/outbuilding to east of unit 3.

10/10/2023 – FULL/2023/1387 – Permission granted to erect single storey detached car port to north boundary.

13/07/2023 – FULL/2023/0729 – Permission granted to erect extension at first floor level to east (side) elevation, erect single storey detached outbuilding/dower unit to west boundary.

22/09/2022 – FULL/2022/1257 – Permission granted to erect single storey extension to south (rear) elevation to Unit 2 and balconies to all elevations of Units 1 & 3.

08/12/2021 - FULL/2021/0013 – Permission granted for variations to plans previously approved to convert and extend packing shed to 3 dwellings with associated landscaping and parking - increase footprint of Units 1 and 3, alteration to fenestration of unit 2 and alter unit boundary lines.

27/04/2021 - FULL/2021/2255 – Permission granted for variations to plans previously approved to convert and extend packing shed to 3 dwellings with

associated landscaping and parking - Erect garage/carport to west boundary and resurface service road.

02/10/2020 - FULL/2020/0926 – Permission granted to convert and extend packing shed to 3 dwellings with associated landscaping and parking.

Conclusion/Brief comment:

Due to its siting, set back from the front elevation of the dwelling and to the east of the dwelling, the garage would not form a prominent feature from public view. The variations to the footprint, design and external materials of the garage are minor in nature and the proposal would have no adverse effects on the character and visual amenity of the area.

Information has been submitted to demonstrate that the design has taken into account the use of energy and resources, in accordance with Policy GP9.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
