NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Subdivide 2 dwellings to create 2 flats and associated works (Protected Building).

LOCATION: Joie de Vivre Flat 1 & The Wing Flat 2, La Grande Maison Road, Vale.

This permission is granted under the terms of Sections 15 and 16 of the Land Planning and Development (Guernsey) Law, 2005 (the 'Law').

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 14/08/2028 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any

other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. A copy of any consultation responses made under section 11 will be included with this decision in accordance with section 19 of the Ordinance.

OFFICER'S REPORT

Brief Description of the site:

The application site comprises a large detached Victorian dwelling with an attached wing that has been subdivided to form a residential dwelling (Ref: FULL/2023/1461).

The site is situated to the south of La Grande Maison Road and to the east of Pleinheume Road. To the east a large outbuilding is situated which in 2010 was converted into a dwelling. Surrounding the site the area comprises residential properties in all directions with open field beyond to the south and southeast.

The site is situated Outside of the Centres as designated in the Island Development Plan. The whole of the building together with the outbuilding and roadside wall and railings are protected.

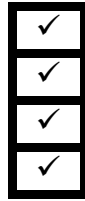

Conclusion/Brief comment:

Retrospective planning permission was granted to subdivide the dwelling to form two residential dwellings in 2023 (ref: FULL/2023/1461). Planning permission is now sought to alter the internal layout of the units, with part of the upper floor of the attached wing accommodation transferred to the larger residential unit (to form an ensuite bathroom), resulting in the creation of two flats. To achieve this, the only alteration relates to the opening of an internal party wall on the second floor between the two units. The alteration proposed has been kept to a minimum and will result in only a small section of the wall being altered. The proposal would have minimal harm on the special interest of the protected building and accords with Policy GP5 of the IDP.

No other alterations (internal or external) are proposed as part of the application and the amenity space for each unit and parking will remain unaltered. The principle of the subdivision has been previously established and the proposal will continue to provide a good standard of accommodation and good amenity for both residential units.

Although views from the rooflight situated in the proposed ensuite would be towards the garden area of the wing accommodation unit, given the height of the rooflight from the internal floor level and its position on the roof elevation, any views would be limited and not so substantial to warrant the refusal of planning permission. The proposal would not harm the amenities of any neighbouring properties or affect the current level of amenity/interrelationship between the two units.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.

The application is acceptable in relation to the above policies and other material planning considerations.
