NOTIFICATION OF GRANT OF PLANNING PERMISSION

PROPOSALS: Raise roof and extend to create accommodation at 1st floor level, extend and alter at ground floor level.

Conditions and reasons:-

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

Expiry Date: This permission will cease to have effect on 18/03/2029 unless development is commenced by that date.

ADVICE AND OTHER REMARKS:-

Effect of planning permission:

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

- (1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).
- (2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.
- (3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.
- (4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.
- (5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

Right of appeal against planning decisions:

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. OFFICER'S REPORT

Brief Description of the site:

The property known as 'The Willows' is a 1970's bungalow, which is the end dwelling on an access road serving three other properties situated off Le Foulon. The property faces southwest with the vehicular access coming from the southeast. The neighbouring properties are to the southeast and northeast with a staff block at St Pierre Park to the north. To the south is a garden centre/nursery. The property is located Outside of the Centres as defined in the Island Development Plan.

There is no relevant history pertaining to this application.

Conclusion/Brief comment:

This application is to extend and alter some elements at ground floor level and raise and alter the roof form to create first floor accommodation. The ground floor extends slightly at the front of the property to enlarge and open up the ground floor layout, with a single lean-to garage being added to the southeast elevation. The new first floor will house three bedrooms, a study and two bathrooms.

There are some exempt works, changes in the fenestration, which will not be discussed in this report.

Initially the proposed roof was a very shallow pitched roof which sat high over the top of the first-floor windows which was not considered good design, the application

was deferred to ask for the roof to be altered to alleviate concerns relating to the roof line.

Amended drawings have since been submitted which show the ridge height the same but the roof has a slightly steeper pitch bringing the fascia closer to the top of the first-floor windows. These changes have improved the overall aesthetics enough for the design to comply with policy.

The property cannot be seen from many public vantage points and as the property is outside of the centres and there are less prescriptive controls over design. The proposals are considered to achieve a reasonable standard of design, using materials which complement the existing materials. The extensions will provide adequate levels of sunshine and daylight, and give the occupiers more flexible and adaptable accommodation.

The scale and massing of all of the new proposals are not considered to have a detrimental effect on the character and amenity of the surrounding area, nor will they have an unacceptable adverse impact on neighbours.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
