## **NOTIFICATION OF GRANT OF PLANNING PERMISSION**

**PROPOSALS:** Demolish outbuilding, erect single storey outbuilding to south-east boundary and erect fence/screening to west of outbuilding.

**Conditions and reasons:-**

1.All development authorised by this permission must be carried out and must be completed in every detail in accordance with the written application, plans and drawings referred to above. No variations to such development amounting to development may be made without the permission of the Authority under the Law.

Reason - To ensure that it is clear that permission is only granted for the development to which the application relates.

2.The development hereby permitted shall be begun within 3 years from the date of grant of this permission.

Reason - This condition reflects section 18(1) of the Land Planning and Development (Guernsey) Law, 2005 which states that planning permission ceases to have effect

unless development is commenced within 3 years of the date of grant (or such shorter period as may be specified in the permission).

3. The development hereby permitted and all the operations which constitute or are incidental to that development must be carried out in compliance with all such requirements of The Building (Guernsey) Regulations, 2012 as are applicable to them, and no operation to which such a requirement applies may be commenced or continued unless (i) plans relating to that operation have been approved by the Authority and (ii) it is commenced or, as the case may be, continued, in accordance with that requirement and any further requirements imposed by the Authority when approving those plans, for the purpose of securing that the building regulations are complied with.

Reason - Any planning permission granted under the Law is subject to this condition as stated in section 17(2) of the Land Planning and Development (Guernsey) Law, 2005.

**Expiry Date: This permission will cease to have effect on 12/03/2029 unless development is commenced by that date.**

#### **ADVICE AND OTHER REMARKS:-**

For the avoidance of doubt, this decision permits the proposed outbuilding hereby approved to be used only for purposes incidental to the enjoyment of the dwelling house, unless in accordance with a use permitted under the Land Planning and Development (Exemptions) Ordinance, 2023 or any other Ordinance replacing or re-enacting that Ordinance.

#### **Effect of planning permission:**

Section 18 of the Land Planning and Development (Guernsey) Law, 2005 ('the Law') defines the effect of the planning permission hereby granted, namely:

(1) Planning permission ceases to have effect unless the development permitted by it is commenced within a period of three years immediately following the date on which it is granted (or such shorter period as may be specified in the permission).

(2) Planning permission enures for the benefit of the land concerned and of every person for the time being having an interest in it.

(3) Any conditions subject to which planning permission is issued are enforceable in accordance with the provisions of Part V of the Law.

(4) Planning permission for the erection of a building is only permission to use it for the purpose specified in the permission or, subject to any restriction so specified, for any other purpose for which it is designed.

(5) Planning permission is only permission to carry out the development specified in it (subject to any conditions so specified), and does not imply the giving of any other approval or consent required under this Law or any other enactment or under any rule of law.

**Right of appeal against planning decisions:**

Your attention is drawn to the provisions of Section 68(1) of the Land Planning and Development (Guernsey) Law 2005, which provides a right of appeal, on the merits against a decision to grant planning permission subject to conditions (except a building condition), to the Planning Tribunal, which is independent of the States of Guernsey. An appeal to the Planning Tribunal under section 68 of the Law against this decision must be made before the expiry of the period of six months beginning with the date on which the Authority made this decision. ## OFFICER'S REPORT

### Brief Description of the site:

The property known as 'Montville de Haut' is a large detached house which was extensively remodelled in 2014. The house sits within a large plot, with a private access drive running along the north boundary, the vehicular entrance in the northeast corner and Ruelle Godfrey (a track) running along the eastern boundary at a higher land level. There are three other large residential properties to the north, east and south and a new housing development to the east on the other side of the track. The property is located in the St Peter Port Main Centre Outer Area as defined in the Island Development Plan.

### Relevant History:

FULL/2020/1922 - Erect detached garage to south-east (side) of dwelling, install cladding to first floor level of dwelling, erect pergola, extend raised patio area and install fencing and gate – Approved November 2020.

FULL/2019/2606 - Erect 2 pergolas to south (rear), erect fencing and alterations to entrance gate and pillars – Approved March 2020.

Residential use class 1: dwelling house.

**Conclusion/Brief comment:**

This application is to demolish the existing outbuilding and replace with a new single storey flat roof outbuilding which will house an entry, a shower room, and a gym. And erect timber screening to west of outbuilding.

The existing outbuilding is 3.7m x 7.35m and is located in the southeast corner of the site, the new gym will be 4.7m x 9.3m and will be situated in the same location, and with a flat roof the proposed structure is considered to achieve a good standard of design.

The new outbuilding is not considered to have any detrimental impacts on the character and appearance of the surrounding character, nor will it have any adverse effects on neighbour amenity.

The outbuilding is nestled into the southeast corner of the site with the eastern track, Ruelle Godfrey, set at a higher level directly to the east of the structure. The land levels help to screen the outbuilding from any passersby, even though the track is seldom used by the general public.

Confirmation has been received that the development proposed has been designed to take into account matters of energy efficiency and current Building Regulations in accordance with Policy GP9.

The proposals are considered to conform to the above policies of the Island Development Plan and grant of permission is recommended, subject to conditions.

All material considerations as set out in the Land Planning and Development (Guernsey) Law, 2005 and the Land Planning and Development (General Provisions) Ordinance, 2007 have been taken into account in the assessment of this application.
